EXECUTIVE ORDER NUMBER 10-121

WHEREAS, the Honorable R. J. LARIZZA, State Attorney for the Seventh Judicial Circuit of Florida, has advised Governor CHARLIE CRIST that Jason Slimak has been charged with violation of probation, violations of the criminal laws of the State of Florida; and

WHEREAS, the Honorable R. J. LARIZZA has also advised the Governor that his wife is the victim in the underlying offense of carjacking; and

WHEREAS, the Honorable R. J. LARIZZA, to avoid any appearance of conflict of interest or impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and potential prosecution of this case and all related matters; and

WHEREAS, the Honorable BRAD KING, State Attorney for the Fifth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interest of the State of Florida and of the ends of justice that the Honorable BRAD KING discharge the duties of the Honorable R. J. LARIZZA, pursuant to Section 27.14, Florida Statutes;

NOW, THEREFORE, I, CHARLIE CRIST, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to

the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable BRAD KING, State Attorney for the Fifth Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable R. J. LARIZZA, State Attorney for the Seventh Judicial Circuit of Florida, as they relate to the investigation, potential prosecution and all matters related to that Jason Slimak.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Seventh Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed above.

Section 3.

All residents of the Seventh Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including June 8, 2011.

Section 5.

The Assigned State Attorney shall notify the Governor on or before May 8, 2011, if additional time is required.
