To Whom It May Concern,

The following request is being made in accordance with Florida Public Records Law (Fla. Stat. sec. 119) and all other Florida open record laws. I am requesting copies of the following:

Reimbursements: Copies of all reimbursement requests made by Lt. Gov. López-Cantera from 02/03/2014, to present. In addition, I am requesting copies of all logs that indicate which reimbursement requests were granted and the amount reimbursed to Lt. Gov. López-Cantera.

Office Expenses: Copies of all expenditures of Lt. Gov. López-Cantera's office in Tallahassee for furniture, computers, televisions, fax machines, copy machines, and cell phones from 02/03/2014, to present.

Travel Logs/Itineraries: Copies of all travel logs and itineraries of Lt. Gov. López-Cantera from 02/03/2014, to present. Records should detail the date and time of travel, the destination, the purpose of travel and meeting, and who Lt. Gov. López-Cantera met as available.

Outlook Calendar: Copies of all outlook calendars of Lt. Gov. López-Cantera from 02/03/2014, to present.

Schedules: Copies of both published and unpublished schedules kept by Lt. Gov. López-Cantera's office, as available.

Scheduling Documents: Copies of all scheduling documents (including emails) of Lt. Gov. López-Cantera's secretary/scheduler regarding any meetings scheduled from 02/03/2014, to present.

Annual Reports: Copies of any annual reports produced by Lt. Gov. López-Cantera's office that track all official activities conducted over the course of that year.



State Vehicle Expenses and Logs: Copies of all travel expenses, travel reimbursements, and travel logs related to Lt. Gov. López-Cantera's (or a member of his family's) usage of any state-owned vehicle from 02/03/2014, to present. Travel logs should detail the date and time of usage, the destination, the number and identity of the occupants, the model of the vehicle, and the estimated distanced traveled as available.

State Plane Expenses and Logs: Copies of all expenses, reimbursements, and travel logs related to Lt. Gov. López-Cantera's (or a member of his family's) usage of any state-owned vehicle from 02/03/2014, to present. Travel logs should detail the date and time of usage, the destination, the number and identity of the occupants, the model of the plane, and the estimated distanced traveled as available.

State Police and Trooper Usage Records: Copies of records that detail all state police and trooper units assigned to accompany Lt. Gov. López-Cantera when he is outside of his state office from 02/03/2014, to present. These records should detail the number of officers assigned, the date when they were assigned to Lt. Gov. López-Cantera, the hours of security protection provided to Lt. Gov. López-Cantera, and the estimated cost of such services being provided.

Private Security Expenses & Reimbursements: Copies of all expenses related to any private security services provided to Lt. Gov. López-Cantera outside of his state office from 02/03/2014, to present. Please also include all related reimbursement requests submitted by Lt. Gov. López-Cantera (or his staff) for such security services being provided.

Personal Financial Disclosures: Copies of all personal financial disclosure forms (also sometimes referred to as "conflict of interest forms" or "statement of economic interest forms") of Lt. Gov. López-Cantera from 02/03/2014, to present.

Salary & Other Compensation: Copies of records that detail Lt. Gov. López-Cantera's salary, deferred salary, retirement benefits, and other compensation (including insurance plans) from 02/03/2014, to present.

List of Boards and Commissions: I am requesting a list of any and all boards and commissions that Lt. Gov. López-Cantera serves as a member of throughout his tenure as Lt. Governor.

Personnel Records: Copies of all records that list the personnel who work in the Office of the Lt. Governor in Tallahassee, from 02/03/2014, to present. These records should include the duration of employment, the position held, and the annual salaries of employees.

Gifts: Copies of all gifts made to Office of the Lt. Governor in Tallahassee and to Lt. Gov. López-Cantera from 02/03/2014, to present. These records should include the name of the giver, the estimated value of the gift, the date given, and the description of the gift as available.

Letters of Reference: Copies of all letters of reference submitted by Lt. Gov. López-Cantera in his capacity as Lieutenant Governor from 02/03/2014, to present. This includes all letters of reference



submitted by Lt. Gov. López-Cantera that were made on correspondence that had the Florida Lt. Governor letterhead on it.

Incoming-And-Outgoing Email Correspondence From The Office Of The Lieutenant Governor To The Email Addresses Listed Below. I am requesting all incoming-and-outgoing email correspondence from the Office of the Lieutenant Governor from 02/03/2014, to present, to the email addresses listed below. I realize that certain costs may be applicable to this request. Please contact me when you can provide a payment amount for my requests. In the meantime, I authorize an initial expense cap of \$500 to be accrued. To help assess my status for copying and mailing fees, please note that I am gathering information for research purposes and not for commercial activities.

I also request that you state the specific legal and factual grounds for withholding any documents or portions of documents, should you withhold any. Please identify each document that falls within the scope of this request but is withheld from release.

If requested documents are located in, or originated in, another installation or bureau, I would request that you please refer this request, or any relevant portion of this request, to the appropriated installation or bureau.

To the extent that the information is available in electronic format, I would prefer to receive that information via email or CD, particularly if providing the information reduces the time or expense involved. Otherwise, I request to receive the information in paper form.
