Hurricane Michael

Dear Mr. President:

Under the provisions of Section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C §§5121-5207 (the "Stafford Act"), as implemented by 44 C.F.R. §206.36, I request that you declare a Major Disaster for the State of Florida as a result of Hurricane Michael to include Individual Assistance, all categories of Public Assistance, as well as Hazard Mitigation. This request is timely under 44 CFR §206.36(a).

On October 8<sup>th</sup>, I requested a pre-landfall Emergency Declaration because of the threat posed by the storm. On October 9<sup>th</sup>, the President granted the request and declared EM-3405, which authorizes Direct Federal Assistance and Categories A and B of Public Assistance for the following, fourteen counties: Bay, Calhoun, Franklin, Gadsden, Gulf, Hamilton, Jackson, Jefferson, Leon, Liberty, Madison, Suwannee, Taylor, and Wakulla.

I request that the incident period for this disaster start on October 7<sup>th</sup>, the beginning date for EM-3405. And as with the Emergency Declaration, I request that the Major Disaster Declaration include the fourteen counties listed above.

# I. The Disaster is So Extraordinary that a Higher Federal Cost Share is Warranted - 44 CFR §206.47

Given the size, strength, and track of the storm, and given the fact that Florida communities are still recovering from Hurricane Hermine (DR-4280 declared September 28, 2016), Hurricane Matthew (DR-4283 declared October 8, 2016), and Hurricane Irma (DR-4337 declared on September 10, 2017), I specifically request the following:

- 100% Federal cost share for Categories A and B (Debris Removal and Emergency Protective Measures) for the first 60 days, with a 90% Federal cost share thereafter see 44 CFR §206.47(d);
- Transitional Sheltering Assistance (Category B); and,
- 90% Federal cost share for all other categories of Public Assistance (Permanent Work Categories C-G) see 44 CFR §206.47(b).

### II. The Disaster is a Catastrophe of Unusual Severity and Magnitude When Field Damage Assessments are not Necessary - 44 CFR §206.36(d)

Given the size, strength, and track of the storm, I specifically request the following:

- Expedited processing; and,
- A disaster declaration without the use of any damage assessments see 44 C.F.R. §206.36(d).

For this disaster, there is no need for damage assessments. The destruction from a major hurricane with 155 mph sustained winds and up to 13 feet of storm surge should be more than sufficient to satisfy any arbitrary, per capita threshold for State or county damages.

On the State side, the impacts to Bay and Franklin counties alone should be more than enough the meet the \$27 million threshold for Public Assistance; and, the needs of the survivors in those counties should paint a sufficient picture for an Individual Assistance declaration.

On the local side, even if a county were to be included as part of the declaration without meeting its threshold, Federal assistance would only be possible if:

- For Public Assistance the applicant can tie damage to the storm; and,
- For Individual Assistance the survivor can demonstrate a need caused by the storm.

Consequently, the risk that a lightly impacted county would receive unnecessary Federal assistance is minimal, at best. Given these considerations, damage assessments would be a clear waste of resources during a time of critical need.

III. The Situation is of Such Severity and Magnitude that Effective Response is Beyond the Capability of the State and the Affected Local Governments - 44 CFR §206.36(b)(1)

#### A. Hurricane Michael

Earlier today, Hurricane Michael made landfall near Mexico Beach as a Category 4 hurricane. With maximum sustained winds of 155 miles per hour (just below Category 5 strength), storm surge of up to 14 feet, and a minimum central pressure of 919 mb, Hurricane Michael inflicted catastrophic damage on Florida's northern Gulf Coast.

Currently, Hurricane Michael is travelling north through the Panhandle and Big Bend regions of Florida and is forecast to still be a hurricane when it exits the State. Of note, many of Big Bend cities and towns facing devastation from Hurricane Michael are still recovering from Hurricane Hermine's impacts from two years ago.

Finally, the forecast calls for Hurricane Michael to travel toward the South Carolina and North Carolina coasts. This could lead to significant tropical moisture flowing northward ("training"), bringing heavy rainfall to the Florida Peninsula communities that experienced significant flooding during Hurricane Matthew in 2016 and Hurricane Irma in 2017.

#### B. State of Florida Government

As of the date of this request, the State of Florida has expended close to \$40 million on response costs alone; State offices in 35 counties are closed; and, I have activated 3,500 of the Florida National Guard.

#### C. Local Governments

As of the date of this request, 35 counties in the State of Florida declared local states of emergency; at least 22 counties opened shelters; and, at least 27 counties ordered evacuations.

IV. Federal Assistance Under the Stafford Act is Necessary to Supplement the Efforts and Available Resources of the State, Local Governments, Disaster Relief Organizations, and Compensation by Insurance for Disaster-Related Losses - 44 CFR §206.36(b)(2)

As of the date of this request, the State has requested the following forms of Direct Federal Assistance through Resource Request Forms ("RRF's):

- Life Sustainment- Mass Feedings
- Disaster Medical Assistance Team
- AmeriCorps Disaster Response Team
- Multi Agency warehouse needs
- Federal USAR Assets to Maxwell Air Force Base

In addition to the assistance listed above, I anticipate a significant need for other forms of supplementary Federal assistance in the days and weeks to come.

V. Confirmation That the Governor Has Taken Appropriate Action Under State Law and Directed the Execution of the State Emergency Plan - 44 CFR §206.36(c)(1)

On October 7, 2018, I issued Executive Order 18-276 and directed the State Coordinating Officer to execute the State's Comprehensive Emergency Management Plan.

VI. Information Describing the Nature and Amount of State and Local Resources Which Have Been or Will Be Committed to Alleviate the Results of the Disaster - 44 CFR §206.36(c)(3)

On October 7, 2018, the State Emergency Response Team ("SERT") activated to a Level 2 – with Emergency Support Functions staffed on an as needed basis. On September 8, the SERT activation level increased to Level 1 – with all Emergency Support Functions fully staffed.

To date, State agencies have expended almost \$40 million in response costs for Hurricane Michael. Given the timing of this request, accurate figures from impacted local governments are not yet available.

VII. Certification by the Governor That State and Local Government Obligations and Expenditures for the Current Disaster Will Comply With All Applicable Cost Sharing Requirements of the Stafford Act - 44 CFR §206.36(c)(5)
