WHEREAS, the State of Florida mourns the loss of life and ensures that the victims of this senseless tragedy will never be forgotten; and

WHEREAS, the entire state of Florida has come together to stand boldly with Orlando and the Central Florida community against terrorism; and

WHEREAS, we are grateful for the extraordinary efforts of our first responders who were on the scene within minutes to provide assistance to the injured and victims of the shooting; and

WHEREAS, we should express our profound sympathy to the families who lost loved ones during this tragic incident and remember that Floridians are resilient and will remain united even during the darkest times of our State's history; and

NOW, THEREFORE, I, Ron DeSantis, Governor of the State of Florida, by virtue of the power and authority vested in me by 4 U.S.C. § 7(m), as amended on June 29, 2007, and the laws and Constitution of the State of Florida, do hereby:

- Acknowledge June 12th as Pulse Remembrance Day in Florida in recognition of the 49 innocent lives lost in the horrific attack on Pulse Nightclub in 2016; and
- 2. Establish June 12th as a day of remembrance to pay tribute to the 49 innocent lives lost at Pulse Nightclub; and
- 3. Ask all residents of Florida to pause for a moment of silence at 9:00 a.m. on Wednesday, June 12, 2019; and
- Direct all State flags in Florida to be lowered to half-staff from sunrise to sunset on Wednesday, June 12, 2019.
