EXECUTIVE ORDER NUMBER 22-07

(State Attorney Executive Assignment)

WHEREAS, the Honorable BRIAN S. KRAMER, State Attorney for the Eighth Judicial Circuit of Florida, has advised Governor RON DESANTIS that complaints have been filed against Clovis Watson, IV for driving while license suspended or revoked, criminal mischief, and robbery by sudden snatching and aggravated battery on a pregnant person; and

WHEREAS, the Honorable BRIAN S. KRAMER has also advised the Governor that Clovis Watson, IV is related to the sheriff of Alachua County; and

WHEREAS, the Honorable BRIAN S. KRAMER, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable JOHN F. DURRETT, State Attorney for the Third Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable JOHN F. DURRETT discharge the duties of the Honorable BRIAN S. KRAMER pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable JOHN F. DURRETT, State Attorney for the Third Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable BRIAN S. KRAMER, State Attorney for the Eighth Judicial Circuit of Florida, as they relate to the investigation, prosecution, and all matters related to Clovis Watson, IV.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Eighth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.


Section 3. All residents of the Eighth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including January 13, 2023.

Section 5. The Assigned State Attorney shall notify the Governor on or before December 13, 2022, if additional time is required.
