

# STATE OF FLORIDA

## OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 23-69 (State Attorney Executive Assignment)

**WHEREAS**, the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Seventeenth Judicial Circuit of Florida, has advised Governor RON DESANTIS that Aileen Penate Hernandez was arrested for misdemeanor battery; and

**WHEREAS**, the Honorable KATHERINE FERNANDEZ RUNDLE has also advised the Governor that the victim and the defendant are related to an employee of the state attorneys' office; and

**WHEREAS**, the Honorable KATHERINE FERNANDEZ RUNDLE, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Aileen Penate Hernandez; and

**WHEREAS**, the Honorable HAROLD F. PRYOR, State Attorney for the Seventeenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

**WHEREAS**, it is in the best interests of the State of Florida and of the ends of justice that the Honorable HAROLD F. PRYOR discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, pursuant to section 27.14, Florida Statutes.

**NOW, THEREFORE, I, RON DESANTIS**, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable HAROLD F. PRYOR, State Attorney for the Seventeenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Seventeenth Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Aileen Penate Hernandez.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Seventeenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3. All residents of the Seventeenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including April 21, 2024.

Section 5. The Assigned State Attorney shall notify the Governor on or before March 21, 2024, if additional time is required.
