OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 23-74 (State Attorney Executive Assignment)

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Eleventh Judicial Circuit of Florida, has advised Governor RON DESANTIS that Melanie Lyn Davis has a pending restitution hearing; and

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE has also advised the Governor that the State Attorney for the Seventeenth Judicial Circuit handled the original case and subsequent violations of probation under Executive Orders 11-200, 17-39, 15-177 and 22-106; and

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Eleventh Judicial Circuit, has advised the Governor that the original conflict continues to exist as Melanie Lyn Davis is related to an employee of the state attorney's office; and

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Melanie Davis; and

WHEREAS, the Honorable HAROLD F. PRYOR, State Attorney for the Seventeenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable HAROLD F. PRYOR discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable HAROLD F. PRYOR, State Attorney for the Seventeenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Eleventh Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Melanie Lyn Davis.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Eleventh Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.


Section 3. All residents of the Eleventh Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including April 21, 2024.

Section 5. The Assigned State Attorney shall notify the Governor on or before March 21, 2024, if additional time is required.
