EXECUTIVE ORDER NUMBER 23-112

(State Attorney Executive Assignment)

WHEREAS, the Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, has advised Governor RON DESANTIS that Erik Arroyo is under investigation by the Florida Department of Law Enforcement for failure to register as a charitable organization; and

WHEREAS, the Honorable ED BRODSKY has also advised the Governor that he had a personal friendship with Mr. Arroyo prior to his election to public office and currently has a professional relationship; and

WHEREAS, the Honorable ED BRODSKY, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Erik Arroyo; and

WHEREAS, the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable AMIRA D. FOX discharge the duties of the Honorable ED BRODSKY, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Erik Arroyo.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Twelfth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

<u>Section 3.</u> All residents of the Twelfth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including May 22, 2024.

<u>Section 5.</u> The Assigned State Attorney shall notify the Governor on or before April 22, 2024, if additional time is required.
