

# STATE OF FLORIDA

## OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 23-188 (State Attorney Executive Assignment)

**WHEREAS**, the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, has advised Governor RON DESANTIS that Stacey L. Scuderi has a pending motion for early termination of probation; and

**WHEREAS**, the Honorable AMIRA D. FOX has also advised the Governor that the State Attorney for the Fifteenth Judicial Circuit handled the original case Executive Order 16-13; and

**WHEREAS**, the Honorable AMIRA D. FOX has also advised the Governor that the state attorney has a personal and professional relationship with a member of Stacey L. Scuderi's immediate family; and

**WHEREAS**, the Honorable AMIRA D. FOX, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Stacey L. Scuderi; and

**WHEREAS**, the Honorable DAVID ARONBERG, State Attorney for the Fifteenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

**WHEREAS**, it is in the best interests of the State of Florida and of the ends of justice that the Honorable DAVID ARONBERG discharge the duties of the Honorable AMIRA D. FOX, pursuant to section 27.14, Florida Statutes.

**NOW, THEREFORE, I, RON DESANTIS**, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the

Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable DAVID ARONBERG, State Attorney for the Fifteenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Stacey L. Scuderi.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Twentieth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.


Section 3. All residents of the Twentieth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including September 22, 2024.

Section 5. The Assigned State Attorney shall notify the Governor on or before August 22, 2024, if additional time is required.
