Applications must include current contact information, <u>including e-mail addresses</u>, for judges, co-counsel, opposing counsel, and references to facilitate the background investigation that will be conducted by the members of the Commission. Please print to .pdf in lieu of scanning where possible.

Please include with your Application: (1) all letters of recommendation the applicant wishes the Commission to consider, which shall be included as attachments to the original application and the

redacted copy, and shall be included with the applications saved in the transmittal; and (2) any additional information the applicant feels may be helpful to the Commission in assessing the applicant's qualifications. Any such supplemental information shall be included as attachments to the application and redacted application.

The Commission strongly suggests that applications be submitted as soon as they are prepared, and well before the application deadline. Applicants granted an interview will be scheduled in the order in which applications are received.

After the deadline for submitting applications, the Commission will determine which applicants will be interviewed. It is currently anticipated that interviews will be conducted in person at the Broward County Main Courthouse on **Tuesday**, **January 16**, **2024**, although both date and location are subject to change.
