Florida's Five Year Prevention and Permanency Plan State Fiscal Year 2013 – 2014 Progress

Highlights and Accomplishments

- Proclamations were issued by Hillsborough County Board of County Commissioners, City of Tampa, Temple Terrace, and Plant City, all recognizing April as Child Abuse Prevention Month.
- The local, multiagency Keeping Kids Safe Partnership again spearheaded the local Pinwheels for Prevention Campaign. They joined Children's Board of Hillsborough County in partnering with The Glazer Children's Museum to kick off the event on April 1st. This event was attended by Children's Board of Hillsborough County Board members and Executive Director, leadership and other representation from DCF SunCoast Region, Eckerd Community Alternatives, and staff from many Community provider agencies. The CB's Public Relations Dept. worked with the City of Tampa to turn on blue lights over the SunTrust Building, located in downtown Tampa. Over 1,500 individuals attended the Museum on that day and the event had participation by 15 providers giving handouts and resources to parents as well.
- Healthy Families Hillsborough maintained countywide service delivery for the second consecutive year.
- Healthy Start Coalition of Hillsborough County Executive Director Jane Murphy was a member of Attorney General Pam Bondi's Substance Exposed Newborn Taskforce that established the Toolkit to Help Communities Establish and Maintain Substance Exposed Newborn Workgroups.
- The Hillsborough County Domestic Violence Task Force hosted its annual conference. Breakout session topics included human trafficking, working with men who batter, trauma-informed care when working with teens, and how agencies can use social media in their work.
- In the summer of 2014, Children's Board of Hillsborough County, in partnership with several other organizations, spearheaded a community marketing campaign drawing attention to specific types of preventable causes of child accidents, injuries and death (e.g., drowning and water safety, infant sleep positions, abusive head trauma, etc.)
- Tampa Bay Rescue and Restore Coalition provided quarterly CSEC trainings about Human Trafficking (January, April, July/August, and October) for the community. TBRRC coordinates with the Florida Coalition against Human Trafficking for scheduling, invites, and materials for these trainings. Over 730 people were trained in 2014, including staff and/or volunteers from child welfare, DJJ, GAL, hospitals, school social work departments and classroom teaching staff, judiciary, court clerks, the Health Department, and OAG.
- In the beginning of Fiscal Year 2013-2014, Eckerd travelled to Ft. Myers to observe their AARC process and adopted the basic design of their AARC process as our Hillsborough County Process. This involves pre-preparation of a decision summary sheet that outlines all issues to be addressed with the adoptive family. This Decision Summary is provided to the AARC committee and the committee votes on their Decision Summary sheet to approve or deny and provides their vote to the facilitator. The case management agency; the GAL Program and the adoptive applicants all have a turn to speak of the issues in a structured way that cuts down on controversy amongst the parties. The case management agency is provided a written decision within 10 working days of the staffing, if the applicant will be approved or denied.
- We celebrated National Adoption Month in 2014, with 21 children adopted on National Adoption Day. Our theme was "My Forever Family, Adoption = Love". The celebration included a keynote speaker that was previously adopted from our county one day before his 18th birthday. The children of Hillsborough County created beautiful drawing that we could display and enjoyed a craft room; face painter and a balloon twister. The photo booth and catered event was enjoyed by all, young and old.


• In Fiscal Year 2013-2014, Eckerd through our partnership with Camelot is proud to say that we were able to successfully find adoptive families for a good hand full of more difficult to place teens. One teen, S. R. had been in foster care from a very young child. She was traumatized by physical and sexual abuse and her mental health and behavior were constant challenges for all involved. She was matched with the perfect forever family for her when she was 17 years old. There are 5 additional teens that also exhibited challenges whether it was their behavior; mental health, or their developmental difficulties that we are proud to say that we were able to find them their adoptive families. We have a sibling group of 3 that we were able to successfully locate the biological mother after a failed adoption to learn that she had completely turned her life around. The children were reunified with their mother and were "adopted" by her. The children remain stable with their mother today. Overall though, we are happy to say that we met our DCF adoption goal of 270 for 2013-2014 fiscal year!

The Children's Board's Family Resource Centers located at 6 sites throughout the county sponsored events during the month of April to highlight prevention efforts at to enhance awareness of available resources to support families here throughout Hillsborough County.

However, there was no fluctuation in the percentage of PNAs received. Out of the 14,771 reports received, 259 (about 1%) were coded as Parent In Need of Assistance. As a result, partners and providers as well as a designee from the Investigative Support Unit, have assisted this community in obtaining resources for our families as a means of intervention rather than utilization of Child Protective Investigations. The designee at the Hillsborough County Sheriff's Office, Child Protective Investigations Division, continues to review PNA referrals. In these cases, if the circumstances change or elevate, the Hotline is notified and the referral is changed to an investigation. At this time, it is unknown what the recidivism rate is on PNA referrals. However, a process has been implemented to track the referral and outcome through the Florida Safe Families Network. During the 2013-2014 fiscal years, families under investigation by HCSO-CPID for allegations of family violence, substance misuse and/or inadequate supervision were referred to the Diversionary Team through Eckerd Community Alternatives if they had not met the criteria for judicial action. A review of Diversionary statistics reflects of the 4,845 referrals made to the Eckerd Diversion Team, 4,837 referrals were accepted. While these referrals encompass all maltreatments, the majority of the families who engaged in services, experienced all or one of these maltreatments. The Hillsborough County Sheriff's Office received 14,771 reports; of which 766 were Special Conditions reports. Please note**multiple providers may have been involved with these families which could skew the true number of families serviced by one specific provider. Since the onset of this plan, Child Protective Investigators and Supervisors identified the need for prevention support services when the maltreatment supported a need for intervention. At this time, CPIs are encouraged to e
Objective 3.3 Continue to promote best practices and coordination in the child welfare and domestic violence systems of care beginning July 1, 2010.	ongoing	During the last CAPP reporting period, the Family Justice Center of Hillsborough County closed its operations. This multiagency collaborative had been serving as the lead DV provider for CAPP activities in this plan. Since the FJC's closure, the Spring of Tampa Bay – a longtime certified DV shelter - assumed the principle leadership role for coordination of local DV activities. Hillsborough County's Child Welfare/Domestic Violence workgroup has made great progress over the past year. Domestic violence training was facilitated by The Spring and three of our local Batterers Intervention Programs and was provided for over 400 case managers with our local child welfare CMOs. Additional Activities

Interagency Collaboration

- Leadership of local DV planning formerly held by the Family Justice Center of Hillsborough County was assumed by the Spring of Tampa Bay.
- Children's Board of Hillsborough County and Glazer Children's Museum continued to build on their partnership in co-hosting the main community April Child Abuse Prevention Month event at the museum. Many additional partners joined the effort.
- Children's Board of Hillsborough County brought on a new Executive Director, Kelley Parris. By the end of this reporting period, CBHC had partnered with other organizations to create a community awareness campaign regarding preventable causes of child accidents, injuries, and deaths (e.g., drowning, sleep safety).

Proposed Activities for 2014-2015

- Continue with the CBHC's community awareness campaign regarding preventable causes of child accidents, injuries, and deaths.
- Implement the new community training plan on infant mental health/social and emotional development in children ages 0-3.
- If approved, implement federally funded expansion of Early Head Start and Head Start programs.
- Healthy Start Coalition of Hillsborough County will successfully manage the implementation of reformulated Medicaid funding methodologies for the Healthy Start program.

Human Trafficking Activities

Summary of Human Trafficking Activities

Hillsborough County's Domestic Violence Task Force hosted its annual conference in November 2013. Breakout session topics included human trafficking.

Robin S. Latimer, Eckerd Community Alternatives – Hillsborough's Missing Children Specialist, participated in a variety of local Human Trafficking-related activities

- Collaborated with the Tampa Bay Rescue and Restore Coalition that provides quarterly CSEC trainings (January, April, July/August, and October) for the community. TBRRC coordinates with the Florida Coalition against Human Trafficking for scheduling, invites, and materials for these trainings. Over 730 Case managers were trained last year (2014) including Child Welfare and DJJ. GALs, Hospital personnel, School social Workers, Judges, Court clerks, teachers, Health Department personnel, OAGs, and many other community members have attended these trainings. TBRRC also partners with SHOCK Education program and provides trainings to youth in those programs on CSEC (3 girl sessions and 3 boy sessions). This training team has completed those for last year and has been invited to present again for this year.
- Partnered with FBI agent Greg Christopher (Innocence Lost Initiative) on interviews with FC victims
 and provide information as to current youth on run that are suspected of involvement. Hillsborough
 County DJJ HT Liaison, Jesus Sosa, also provides information to Ms. Latimer to forward to Greg
 Christopher when a youth is identified via DJJ.
- Participated in the Human Trafficking Collaborative sponsored by Collaborative Labs @ St. Pete College in February 2014.
- Participated in Clearwater/Tampa Bay HT task force meetings and attended the DJJ Human Trafficking Summit October 2013.
- Participated in the creation of (2013) / and updating of (2014) the Tampa Bay Human Trafficking Emergency Response Protocol in collaboration with Giselle Rodriguez from FCAHT.
- Participated in DJJ Crossover court hearings with Judge Ralph Stoddard each Thursday and work directly with his staff on identification of CSEC youth and coordination of services for these youth identified.
- In the last year, Hillsborough's first CSEC Safe home was opened, Redefining Refuge.





Interagency Collaboration

Eckerd Community Alternatives currently partners with Camelot Community Care, Inc., Wendy's Wonderful Kid's, Inc. through the Dave Thomas Foundation, Sylvia Thomas Center, One Church One Child, Heart Gallery of Tampa Bay and Junior League of Tampa to ensure that three match events occur each year. The match events targets legacy children, teens and sibling groups.

Eckerd Community Alternatives contracts with Heart Gallery of Tampa Bay for recruitment. The Heart Gallery ensures each child has a professional photograph taken. These photographs are uploaded on the Heart Gallery website and Eckerd's website and then the photographs are placed throughout different venues in the Tampa Bay area.

Eckerd Community Alternatives partners with Wendy's Wonderful Kid, Inc. through the Dave Thomas Foundation for recruitment. Hillsborough County has two Wendy's Wonderful Kid's recruiters. These professionals work on caseloads of children the system has forgotten, ensuring they have the time and resources to give each child as much attention as he or she deserves. These recruiters employ aggressive practices and proven tactics focused on finding the best home for a child through the starting points of familiar circles of family, friends and neighbors, and then reaching out to the communities in which they live.

Eckerd Community Alternatives in partnership with One Church Once Child in targeted recruitment for children in Hillsborough County. One Church One Child operates throughout the State of Florida. It is a private, non-profit, faith-based organization that provides adoption related serves and works in partnership with the Florida Department of Children and Families and churches. One Church One Child also collaborates with the Community Based Care Lead Agencies and their provider agencies in recruiting and referring families interested in adopting children from Florida's Foster Care System.

Eckerd Community Alternatives through the partnership with the Junior League of Tampa continues to work on improving permanency for children touched by the child welfare system. The Junior League of Tampa is an organization of over 1,800 women who are committed to promoting voluntarism, developing the potential of women, and improving communities.

Eckerd Community Alternatives partners with the Sylvia Thomas Center to promote permanency by providing comprehensive supports to adoptive and foster families. Sylvia Thomas Center offers support, training and fellowship with other adoptive families. Sylvia Thomas Center also hosts special events with adoptive families, provide local resources and mentor adoptive families.




