**Summary of Plan Activities**

*This workgroup has disbanded in 2012. The workgroup initially decided to work with the Community Based Child Abuse Prevention Program (CBCAP) definition for **evidence-based** for reducing child maltreatment as the ranking criteria. Members discussed increasing child well-being and reducing child maltreatment as identified outcomes with components that increase parenting skills and family functioning. Further thoughts were to include substance abuse, depression and domestic violence as factors to explore. FRIENDS, National Resource Center for CBCAP served as member of the workgroup. Members of the Child Abuse Prevention and Permanency Advisory Council were also members. Initial representation was strong and included representatives from community-based care lead agencies, prevention oriented programs and state agencies.*

*This workgroup disbanded with permission of the former executive director based on inconsistency in researching skills and comprehension, and the formats submitted lent themselves to a questionable quality of product. Another barrier was the hardship of keeping the research up to date. Information regarding the status of the programs themselves changed during the period of research. Limited staff time and resources exacerbated the continual need to ensure the accuracy of the reporting. FRIENDS acknowledged this as a barrier when they published their directory in 2009. It was agreed upon to share the listing of national resources for lists of evidence-based programming.*

**Progress**

Diligent attempts were made to evaluate programs against the promotion of the Protective factors and to display specific ones endorsed by a given parenting program. However, the research was conducted by volunteers with inconsistent levels of researching skills, which led to inconsistent formats and a questionable quality of product. Additionally, volunteers conducted this research in addition to assigned/designated work duties. This workgroup has disbanded in 2012.

71% See above explanation. CAN 3.2.2.6 and CAN 3.2.2.7 were not completed. We suggest including the list of national registries in the Governor's Office of Adoption and Child Protection annual report.

*Do you think your team is on target to accomplishing your objective by June 2015?*

*No. A directional change has been discussed and approved by former executive director to submit a listing of websites promoting evidence-based parenting programs. Due to lay professionals and volunteers collecting the information, there is concern for consistent application of the review and information presented. Integrity of the process is questioned and there are not sufficient resources to secure qualified reviewers to insure accuracy.*
