**In July 2013, the Florida Department of Health included funding in the Healthy Start contracts for training on the Partners for a Healthy Baby Curriculum. Partners for a Healthy Baby is a nationally recognized research based, practice informed curriculum. At the programmatic level the curriculum provides a framework and set of tools to help any environment that supports young children and their families enhance their capacity to build protective factors that promote optimal development and prevent abuse and neglect.**

**By June 30, 2014, staff in all Healthy Start Coalitions were trained on the Partners for a Healthy Baby curriculum.**

**For FY 2015/2016 the Maternal and Child Health Section of the Florida Department of Health put forth a Budget Issue Proposal requesting to restore the Healthy Start general revenue allocation back to the FY 2010/2011 funding level. Healthy Start also continues to be funded by the 1115b waiver which allows for the expansion of the intensity and duration of Healthy Start services .**

**A process known as sequestration, took effect on Mar. 1, 2013, as stipulated by the *Budget Control Act of 2011* (P.L.112-25) and amended by the *American Taxpayer Relief Act* (P.L.112-240). The impact of sequestration on the Title V Maternal and Child Health Services Block Grant (MCHBG) was approximately an 8.9% reduction from the 2013 grant award. The Department of Health was also advised to expect the same reduction for the FY 2014 grant award beginning October, 2014. As a result, the Healthy Start program experienced a similar reduction. MCHBG funding has since been restored by Congress to pre-sequestration levels.**

**The Florida Department of Health in partnership with the Florida Association of Healthy Start Coalitions has worked to reduce administrative costs in an effort to provide more services to clients.**

**It is unknown if general revenue funding levels will be restored to the 2010/11 funding level. Funding is dependent upon legislative appropriations.**

**In FY2013/14, the Florida Department of Health provided funding to the Healthy Start Coalitions to begin training staff on motivational interviewing and elements of the Partners for a Healthy Baby curriculum. Training has since been completed.**

**The 2014 General Appropriations Act (GAA) transferred budget authority in the Federal Grants Trust Fund (Medicaid) and the associated general revenue match for the Waiver/SOBRA programs to the Agency for Health Care Administration (AHCA). The Department worked cooperatively with FAHSC and AHCA to transition the Waiver/SOBRA program to AHCA beginning July 1, 2014.**

**With the balance of general revenue funds appropriated by the Legislature, the Department will continue to work with the Healthy Start Coalitions to address the health and care coordination needs of non-Medicaid**

**enrolled pregnant women and children from birth up to age 3 and to ensure that a Healthy Start system of care coordination is sustained in local communities.**

**The Florida Association of Healthy Start Coalitions has implemented the Healthy Start MomCare Network to operate as the Administrative Services entity to oversee Medicaid funded Healthy Start services.**

**Fetal and Infant Mortality Review: By 30 June 2015, Healthy Start will have put processes in place to have sufficient funding to establish the Fetal and Infant Mortality Review process statewide and will continue to collaborate with the State Child Abuse Death Review Team regarding mutual strategies to reduce child deaths.**

**For FY 2014/2015 the Maternal and Child Health Section put forth a Budget Issue Proposal requesting to restore the Healthy Start general revenue allocation back to the FY 2010/2011 funding level. Included within that request was \$479,248 to enable all Healthy Start Coalitions to facilitate or conduct systematic reviews of fetal and infant deaths by providing funding for 22 additional FIMR teams throughout the state (\$21,784 for each additional FIMR team). During the 2014-15 Legislative Session, the Healthy Start Coalition of Hillsborough County, Inc. was provided \$50,000 in general revenue for an expanded FIMR project.**

**Increased funding for the overall Healthy Start FIMR projects has not changed with the exception of the \$50,000 in general revenue provided to the Healthy Start Coalition of Hillsborough County, Inc.**

In 2011, the Florida Department of Health and the Florida Association of Healthy Start Coalitions began a process implement evidence based curriculums into the Healthy Start core service components. The goal was to increase the delivery of evidence-based services where these services have been shown through a meta-analysis of rigorous evaluations to impact outcomes such as infant mortality, low birth weight babies, and pre-term babies.

Funding to implement statewide training on selected curricula was included in the Healthy Start Coalition contracts for FY 2013-14. Statewide training was completed by June 20, 2014. In addition, the Florida Association of Healthy Start Coalitions (FAHSC) was awarded a Maternal, Infant and Early Childhood Home Visiting (MIECHV) grant in March 2013. Funding from that grant helped fund evidence based education services in Florida. Five counties were currently implementing evidence based programs and six additional counties were selected to implement in October 2013.

Accomplishing the objective is in the process of being met. Each region in Florida has a FAHSC representative that is a trained trainer in the Partners for a Healthy Baby and a SCRIPT trainer. This supports sustainability of training as new staff are hired.

Yes, however, this will be a continual process as staff will turnover and training will continually be needed and as new evidence may arise, curriculums may be updated or changed.
