Highlights and Accomplishments

- Child maltreatment rates continued to decrease for third consecutive year.
- Cross collaboration continues to occur for drowning prevention and safe sleep initiatives. Funding for education and resources continue to be a focus for various funders.
- The Children’s Services Council of Broward County was re-elected through referendum by the voters of the community to remain in existence and continue prevention efforts for the children of Broward County.
- The Domestic Violence sub-committee continues to work on strategic planning goals. The community responded to address domestic violence training needs by hosting the David Mandel Safe and Together training for child welfare professionals throughout the county.
- The rate of adoptions finalized in less than 12 months from termination of Parental Rights continues to increase for the fourth consecutive year while the rate of adoptions occurring after 12 months of TPR continues to decrease.


Desired Population Level Results

1. **Child Maltreatment Prevention** – By June 30, 2015, the verified findings of child abuse rate will be reduced from the State Fiscal Year 2008 – 2009 statewide rate of 10.94 per 1,000 children.

Status of Strategies and Objectives

Strategy A.1: Over the five year period from July 2010-June 2015, Circuit 17 will engage in a comprehensive campaign to educate the community both parents and professionals on Drowning Prevention strategies targeted to the Infant/Toddler age group and Unsafe Sleep Practices which are the leading causes of death in the County.

Objective 1.1 Community wide Drowning Prevention Action Plan	Completed	<p>The Broward County Drowning Prevention Taskforce has developed a strategic plan to address drowning prevention initiatives and action steps.</p> <ul style="list-style-type: none"> During, FY 13-14, cities and funders have identified additional money to increase free lessons for children ages 1-4 years old. First responders are being trained to identify water hazards while on site of a call. Department of Health inspectors are looking at deficits in safety barriers when identified by a first responder. Water Smart Broward website was launched by the Drowning Prevention Taskforce. This website contains all drowning prevention resources, contacts, services, and information on one website so the public can receive all needed information at one location.
Objective 1.2 Community Strategies to eliminate Unsafe Sleep practices	Completed	<p>A safe sleep sub-committee has been formed under the Maternal Child Health Strategic planning committee to have a sole focus on community wide initiatives to address unsafe sleep practices. The sub-committee has developed an initial community plan which includes goals, objectives, and action steps.</p> <ul style="list-style-type: none"> Collaboration with the Ft. Lauderdale Fire Rescue continues with the DOSE (Direct On-Site Training) initiative. They collaborated with Healthy Mothers Healthy Babies to create a training video which is used for first responders. All in-home service staff including Family Strengthening and Child Protection Investigators have been trained to identify risk factors for unsafe sleep environments. In October 2014, CSC began funding a new Safe Sleep Coordinator (RN) position to coordinate trainings and community wide initiatives. This

Strategy C.1: Over the five-year period from July 2010 –June 2015, Circuit 17 will support the statewide efforts to increase the availability and capacity of Healthy Families Florida to provide home visitation for families at high risk of abuse and neglect and in need of parenting education and support.

Healthy Families Broward completed their two year process for Healthy Families America Accreditation renewal which is valid until June 30, 2019.</p> <p>During the year, HFB expanded their High Risk Family Specialist capacity this year from 1 FT person to 1 FT and 1 PT person.</p> <p>Healthy Families hosted their annual graduation event to recognize the families that complete the program successfully. Additionally, the program provides community educational activities in program’s areas of expertise (Shaken Baby, Immunizations, Breastfeeding, Attachment/Bonding, etc) at various community events such as, Broward Aware’s Family Fun and Resource Day and the Fatherhood Bootcamp at the Healthy Start/Memorial Healthcare System Event.</p>

Strategy C.2: Over the five year period from July 2010-June 2015, Circuit 17 will implement strategies to strengthen the Maternal/Child Health service outreach with the promotion of the Safe Baby Campaign.

Objective 1.1 To implement a uniform eligibility system to increase access and enrollment of eligible clients to public assistance programs as well as healthcare and human services.		<p>The Common Eligibility Project is a collaborative effort with multiple Broward partners to identify benefit enrollment opportunities across healthcare and social service systems and share the associated costs. One-e-App is an electronic common eligibility and enrollment platform for Broward County individuals and families to access vital health and human services from multiple Federal, State and County programs using a single streamlined application form. One -e-App enables instant submission of electronic applications for Medicaid, SNAP and TANF to the Department of Children and Families</p> <p>For the period ended 9/30/14, there were 1,217 client interviews, representing 2,759 unduplicated people, both adults and children entered into the System to review eligibility for 6,772 programs.</p> <p>Organizations using One-e-App have seen significant benefits such as increases in efficiency and reductions in service duplication. By using a single streamlined application, individuals and families no longer need to travel to different agencies and locations to enroll in these services. Many times One-e-App consumers are made aware of, and often enrolled in, programs they never knew about or knew they were eligible for.</p>

Strategy D.4: Over the five year period from July 2010-June 2015, Circuit 17 will engage in a Public Awareness Campaign aimed at reducing Abuse and Neglect.

Objective 1.1 To implement a Public Awareness Campaign which leverages the community's resource to prevent child abuse and neglect.	Completed/ On-going	<p>The Broward AWARE, Protecting Our Children campaign works as part of the CAPP Planning Committee to raise public awareness on the resources available to help prevent child abuse and neglect and heal its victims. Broward AWARE encompasses nearly 30 agencies and organizations working in this arena and leverages public awareness resources to reach a broad audience of families, educators, public servants, policy makers, law enforcement officials, media and other stakeholders. It partners with the Centralized Information and Referral System – 211 with a dedicated webpage on the 211 site that includes a calendar of events, interactive resources, presentations materials, etc.</p> <p>The Broward AWARE campaign launches in January with a press conference and culminates in April, with a Family Fun and Resource Fair in conjunction Child Abuse Prevention Month activities and state and national Pinwheels for Prevention events.</p> <p>Leverage activities, resources from community members such as parenting groups, training on child development, concrete supports.</p>

Human Trafficking Activities

Summary of Human Trafficking Activities

Coalition was formed in 2008. It has identified community indicators through regularly held meetings to review identified cases. It has provided community trainings across the county to social services professionals, law enforcement. The STARS Committee (Stop Trafficking and Rescue Survivors) was formed as part of the coalition. It is solely focused on the juvenile aspects of human trafficking. The STARS committee has actively been working to identify gaps in service provision, and work to ensure that there are POCs (points of contact) that will work together to enhance service provision to juvenile victims. The STARS Committee is being recognized as a leader in the development of policy and positive adaptive change for juveniles. The DJJ Circuit 17 and Broward JAC-BSO (representing the STARS subcommittee) assisted in the current development of the DJJ and DCF statewide Human Trafficking assessment tool that is soon to be released. This tool will be utilized to identify youth who are at risk for sex trafficking as well as labor trafficking. The efforts undertaken are to address the systems for those youth who are identified as either domestically or internationally trafficked. Education and awareness are the hallmarks of the BHTC. This Committee receives direction, networking, and information to work diligently to collaborate and coordinate responses within their respective agencies to issues such as Domestic Minor Sex Trafficking. <http://www.bhtc.us/>





Strategy 1: By June 30, 2015, Circuit 17 will reduce the time from TPR to adoption finalization of African American children.

Objective	Status	Summary/Action Needed
Objective 1.1 Identify organizations, community groups, and churches that provide support and outreach to this population.	On-going	For FY 2013 - 2014 <ul style="list-style-type: none"> During this fiscal year, FaithNet has seen a change in leadership and is not as focused as earlier years. One Church One Child has renewed activity in Broward county and will be working to develop relationships within churches and bring awareness to adoption. In October 2013, Global Outreach Ministries a mentorship and leadership series for the women of its congregation, and invited young ladies from Foster care and independent living youth to attend.
Objective 1.2 Once such groups have been identified, establish ongoing contact to increase adoption awareness.	On-going	All children available for adoption with no identified adoptive placements are listed on all of the adoption websites. The adoption recruitment supervisor notifies Home Finder of recently TPR'd children with no identified placements within 24 hours of receiving notification from TPR supervisor. The Home Finder and Wendy's wonderful kids recruiters continue to conduct targeted recruitment efforts among all the resources that result from these efforts.

Strategy 2: By June 30, 2015, Circuit 17 will reduce the wait time for sibling groups who need to be adopted together.

On-going	For FY 2013 - 2014 <ul style="list-style-type: none"> ChildNet and Broward's Heart Gallery partnered to feature Broward sibling groups in the gallery WWK recruiters provided enhanced recruitment through the Dave Thomas Grant for 5 challenging sibling groups (totaling 17 children) and is anticipated to achieve permanency for 6 of these groups, keeping all or some of the sibling connections in tact Separation of sibling staffings are conducted at within 30 days of initial intake to address when children are separated based on placement limitations; if missed staffings are again revisited after goal change to adoption to determine efforts to preserve the sibling group.

Strategy 3: By June 30, 2015, Circuit 17 will reduce the wait time for children over the age of 8 to be adopted.

Objective 3.1 Increase the number of approved adoptive families interested in adopting children over 8.	On-going	<ul style="list-style-type: none"> • ChildNet continues to prioritize admissions to the MAPP classes to prospective adoptive families who have expressed an interest in adopting a child over the age of 8. • ChildNet continues to host monthly Adoption Orientation and Pre-service trainings (MAPP) for prospective adoptive families. Over 140 prospective adoptive families attended the monthly Orientations during the fiscal year, with 66 families moving on to have adoption home studies completed. • ChildNet's Homefinder and WWK recruiters worked with partners Broward Heart Gallery and Forever Families to host matching events for older children, as well as feature older waiting children engaged in fun activities throughout the year.

Additional Activities

Interagency Collaboration

- Broward County's Heart Gallery a private non-profit managed by its own Board of Directors. We share an active partnership through co hosting of fun filled photo shoots at interactive locations, matching events with waiting families and children, and collaborating about general and targeted recruitment.
- ChildNet also continues to partner with Forever Families to feature waiting children on the local NBC / Channel 6 news to generate child specific interest and bring attention to children waiting to be adopted from Foster Care.
- ChildNet has 2 Wendy's Wonderful Recruiters, whose positions are grant funded by the Dave Thomas foundation. These recruiters provide targeted efforts for their assigned children based on the foundation's child-specific model of case mining and in-depth review of case history, and outreach to all persons in that child's life to find a connection, and work to develop into adoption resources. They partner with that child's team to research and develop any and every possibility of connection for that child.
- ChildNets adoption team also participates in generalized recruitment by staffing informational booths at community events. Some highlights include :
 - August 2013 Back to School event; a local artist hosted children at a studio in Miami during the Coconut Grove Art festival, to teach about art and have everyone create their own original work. The Heart Gallery sponsored the event and photographed children for the gallery.
 - September 2013 Forever Families arranged for children to ride in a blimp , and children were recorded for their televised recruitment videos
 - October 2013, ChildNet and WWK recruiters hosted a teen matching event at Boomers, a local bowling alley, where families from neighboring counties along with waiting Broward families interested in teens were invited to attend.
 - November 2014 our annual Adoption Appreciation event brought together families who finalized adoptions in the prior year, as well select families who were visiting with newly matched children; local support group leaders led activities and built relationships with local families in an effort build communities of multi-directional support
 - December 2014 Teen Talk ; local community news Beacon TV hosted Teens from foster care and young adults in independent living to talk about their experiences of either waiting to




Status of Strategies and Objectives

Strategy 1: By June 30, 2015, Circuit 17 will increase awareness and accessibility to post adoptive supports and services.

Objective	Status	Summary/Action Needed
Objective 1.1 Adoptive families in Broward County will be supported through post adoption services.	On-going	Adoption advocates and post adoption specialist continue to provide all adoptive families with the post adoption informational packet. Post adoption specialist continues to conduct follow up calls to adoptive parents, 1 month, 6 months and 12 months after finalization. The post adoption specialist attends the support groups with Kids in Distress , Fab Familyz, and FAPA, and most Adoption MAPP panel discussions to talk about the post adoption program Post adoption specialist attends all legal sufficiency staffing concerning adoptive families after finalization, in an effort to advise all parties of interventions and services he may have already provided to families, or offer assistance that may prevent an adoptive child from coming back into foster care .
Objective 1.2 Adoptive families will gain an increased awareness of all available services in the Circuit.	On-going	The Adoption Connection newsletter was distributed to prospective adoptive and adoptive families quarterly during the 2013 – 2014 fiscal year. Objective 1.3 Adoptive families will gain access and availability to adoption competent service providers and support services after finalization.	On-going	ChildNet continues to sub contract with Kids in Distress and Children’s Home Society to provide adoption specific therapy to pre and post adoption families. These contracted services can accompany other Medicaid billed service providers without conflict based on the service contract.

Support of Adoptive Families include:

- ChildNet’s adoption team includes a full time home finder and two full time pre- service training specialists, who conduct a monthly informational orientation meeting for prospective adoptive families, and lead pre service trainings and complete adoption home studies. MAPP is the primary pre service training used for prospective adoptive families, and there are a minimum of 5 MAPP training cycles per fiscal year. Two training cycles occurred during the first quarter, and a third class will start in October.
- The home finder is the primary point of contact for all children listed on web based recruitment sites, and provides preliminary screening for all inquiring families. She facilitates information disclosures between the child’s assigned team and the families, and supports all waiting families through their initial match.
- The training specialists also conduct all courtesy adoption home studies that are requested from other counties and states; they will assess the prospective adoptive candidate’s needs, make training recommendations and ensure that families who have children placed for adoption by other jurisdictions, are connected to all local supports and services.
- ChildNet has a full time dedicated post adoption specialist who meets with all local adoptive families at the time of adoptive placement to introduce the program and the services available after adoption finalization. All families are provided with a resource folder of information at that time.
