Florida's Five Year Prevention and Permanency Plan State Fiscal Year 2013 – 2014 Progress

Highlights and Accomplishments

The Department of Children and Families outreach was very busy in the past year highlighted by the following:

- Appeared numerous times throughout the year on local radio broadcasts and television to raise awareness about child abuse prevention/fatalities, the need for more foster/adoptive homes and who to contact for services.
- Collaborated with School Boards from our four county area to address foster children's needs; suggested challenging school principals to recruit one teacher/staff member from each school to become a foster/adoptive parent.
- Collaborated with Indian River County's Senior Resource Association, who operate the Transit system in IRC, to air PSA's concerning child abuse prevention/fatalities involving drowning, unsafe sleep, hot cars, and who's watching your child. Ridership in Indian River County exceeds 1.2 million people.
- Provided numerous trainings to County schools/nurses and the St. Lucie Parent Academy concerning child abuse, prevention of fatalities, and mandatory reporting. Trainings also occurred with Headstart programs, foster parent associations, many service club organizations and the Guardian Ad Litem program.
- Maintained booths which provided information on child abuse prevention/fatality awareness as well as information on how to become a foster/adoptive parent. A few of the events were Sebastian's National Night Out, Okeechobee's Health and Safety Expo, St. Lucie's Early Learning Coalitions Family Fun Day and CHS National Adoption Day.

Devereux Community Based Care of Okeechobee and the Treasure Coast marked its first anniversary as the area's lead Community Based Care agency November 1. It's been a busy year, highlighted by the following accomplishments:

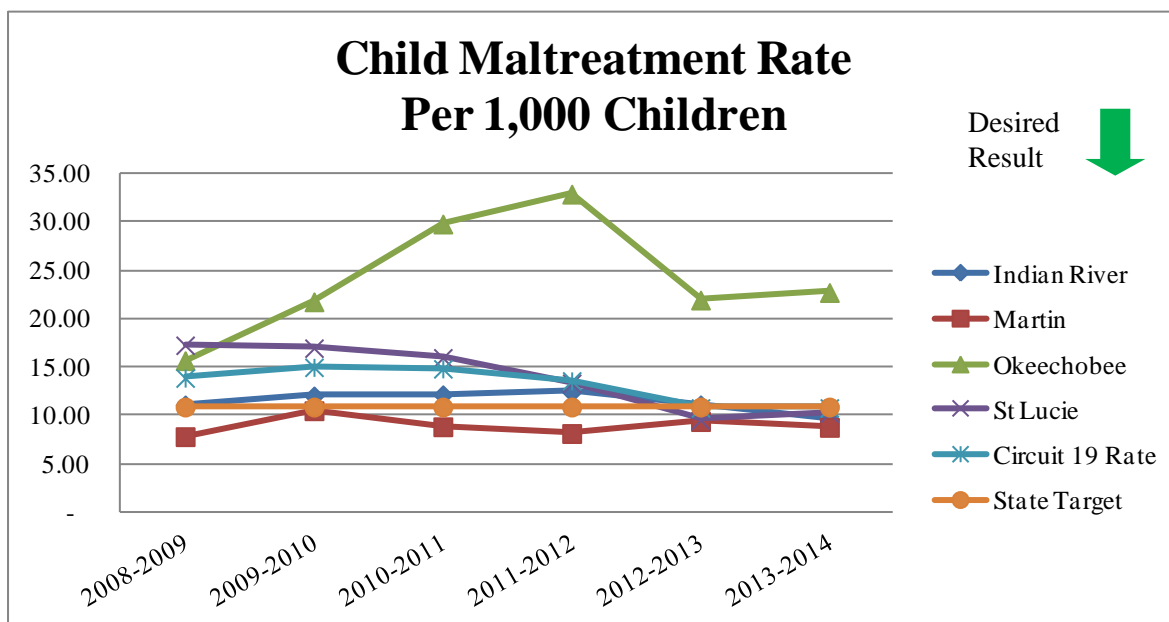
- Strengthened relationships with the local court system and with our partners in child welfare, Child Legal Services and the Guardian ad Litem program.
- Ended the fiscal year in the black despite an initial \$1.5 million deficit.
- Created a viable Utilization Management system to ensure quality care while controlling costs.
- Unrolled our new County Director model of management, positioning key leadership at the local county level.
- Engaged the Annie E. Casey Foundation in bringing the Permanency Roundtable process to Circuit 19 and are holding monthly staffing.
- Stabilized case-manager turnover, particularly in St. Lucie County.
- Were able to initiate a Diversion program in St. Lucie County to provide intensive needed services for families and look to divert them from the dependency system.

CASTLE set up a memorial flag field in Okeechobee to help remember all the children who died as a result of child abuse. The Okeechobee News covered the dedication ceremony giving emphasis on the higher rate of abuse in Okeechobee. The other major news agencies cover the dedication ceremonies as well. The ceremonies continue to occur during the months of March and ending during Child Abuse Awareness month in April. The 2014 County ceremonies were held on : Martin County from 3/7-3/14, Okeechobee 3/14-3/21, Indian River 3/21-3/28, and St. Lucie 3/28 – May 1, 2014 Indiantown was targeted for distribution of the Safe Summer campaign materials and press releases were sent to Spanish language newspapers. Additional Activities

During the Month of April, CASTLE’s 5k- STOMP rased community awareness to over 750 participants in STLC county. The event has become so popular that it will be extended to a 5K and 10K event, therby increasing the participants and community awareness level to over 1000 participants.

Also during the upcoming year April 2015, the STLC School system will be hosting a CASTLE Memory Field at most of their schools. The ability to reach the parents of school age children, regardless of age is tremendous when compared to A the 2013 STLC demographpic profile, there is a potential to reach to parents of the 39,494 students enrolled in schools.

Interagency Collaboration

The Department of Children and Families, along with CASTLE have recognized that the local community maternity wards, Lawnwood, Martin Memorial-Tradition, Martin Memorial North, STLC Medical Center, and Indian River Memorial each, have various methods of engaging new families that have experienced parenthood in regards to Safe Sleep. Therefore the partners and looking to engage each maternity ward in a discussion, that hopefully leads to an extended partnership, which could duplicate a consistent methodology to teach safe sleep. Single parents with multiple children or non-biological caretakers are more at risk for SIDS events. Engaging these family’s in a discussion on safe sleep, to include the paramour or non-parent caregiver could reduce the infant mortality rate in the district. Currently seven of the nine deaths in the Circuit are due to unsafe sleeping conditions.

Okeechobee County’s Raulerson Hospital does not have a maternity ward, and sends all patients to Lawnwood, Sebring, or St. Mary’s Hospital in Palm Beach if it is a high risk pregnancy. All four counties send all high risk pregnancies to St. Mary’s Hospital in Palm Beach. A collaboration between Districts would be beneficial.

Child Maltreatment Prevention

The Department has supplied various material raising community awareness concerning: UnSafe Sleep, Child drowning, and lack of Supervision i.e. Who's Watching Your Baby. The materials will be distributed to the under served areas of the District, Okeechobee and Indiantown, by CASTLE.

Human Trafficking Activities

Summary of Human Trafficking Activities

Circuit 19's STARS (Stop Trafficking and Rescue Survivors) committee has been meeting monthly and the entire Coalition meets on a quarterly basis. All of the CPI's and DCM's have been trained according to the new law. The committee has also trained Guardian Ad Litem and foster parents on the new law and signs to look for. The process of speaking with individual foster children is ongoing.

The STARS committee received several Proclamations from Indian River, Martin, Okeechobee, and the St. Lucie County Commissions as well as several individual municipalities during Human Trafficking Awareness month. PSA's concerning Human Trafficking were sent out to the County Commissions and municipalities to be aired on their public access channels.

Proposed Human Trafficking Activities for 2014-2015

Circuit 19 STARS committee is looking to bring Human Trafficking training to schools and many other organizations in our community.

The Circuit is looking into a special recruitment training specifically for foster parents to become human trafficking homes.

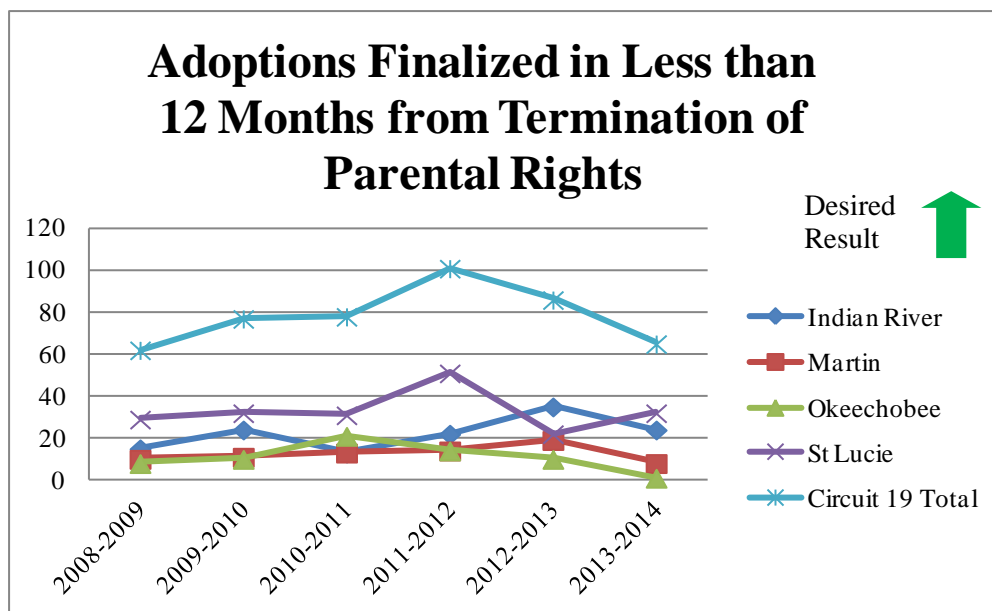

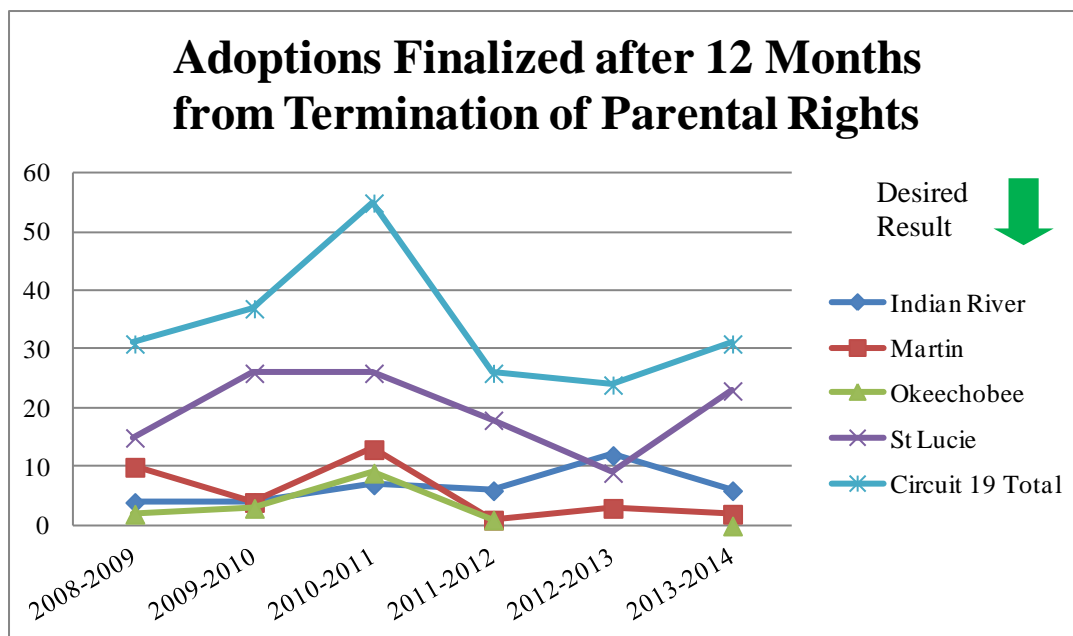

Status of Strategies and Objectives

Strategy 1: By June 30, 2015, Circuit 19 will implement a faith based adoption initiative.

Objective	Status	Summary/Action Needed
Objective 1.1 Circuit 19 will partner with Faith Based organizations to increase the number of local families wanting to adopt foster children who have been in care for long periods by 6/30/2013. This will result in a 25% increase in adoptions of kids in care greater than 24 months by 6/30/2015. Baseline: average of 2008 performance of nine families, and 2009 performance of six local families.	Ongoing	During the State Fiscal Year 2013-14, the promotion of adoption awareness occurred to six faith-based groups/events. In addition, outreach efforts promoting Adoption Orientation are offered to multiple faith-based groups across the circuit via email blast on a monthly basis. Over the year, we identified five families referred to PIP class as a result of our faith-based outreach initiative. Additionally, during the year, we have identified the possibility that additional families may be engaging in PIP class as a result of this initiative but are not being formally reported. Circuit 19 has initiated Permanency Roundtables during this past year assisted by trainings from the Casey foundation.
Objective 1.2 Explore One Church One Child as a potential resource for Faith based families wanting to adopt and also for targeted recruitment for children.	Ongoing	The adoption faith-based liaison continued to collaborate with One Church One Child (OCOC) at the regional/statewide level. During the State Fiscal Year 2013-14, the photos/bios of nine minority/bi-racial children from the circuit were electronically submitted to the regional OCOC office for recruitment efforts. Also, during this time period, a total of three adoption homes studies were received via OCOC for prospective adoptive families. Additionally, OCOC referred three families to CHS to attend our Adoption Orientation. The adoption faith-based liaison continues to work with the OCOC regional/statewide office in an attempt to establish local contacts within this circuit to better promote our minority children within the faith-based community. On December 6 th OCOC is hosting an Adoption prayer breakfast in collaboration with Devereux, CHS, and DCF..

Strategy 2: By June 30, 2015, Circuit 19 will identify inefficiencies and streamline processes in order to expedite permanency for children.

Objective 2.1 Evaluate the average time frames for each phase of the permanency process (entry into care and TPR goal establishment, Goal establishment and TPR finalization, and Finalization and matching with adoptive family) and identify barriers that may exist within each phase.	Ongoing	Circuit 19 has continued their Dependency Model Court to address issues within the Circuit. Devereux has also enlisted the Casey Foundation which came down to provide training to conduct permanency roundtables which have been occurring monthly.

Additional Activities

Interagency Collaboration on Promotion of Adoption

Children's Home Society of Florida's Adoption Program continues to collaborate with Devereux Community-Based Care with the promotion of Adoption by supporting and attending their monthly agency tours. There is also

an interagency with both foster care agencies, Camelot and 4Kids, who are the local entities that facilitate Partnership in Parenting (PIP) classes for all prospective local adoptive families. CHS also attends the final PIP class by participating on the agency panel during that session.

Devereux Community Based Care coordinated breakfast in all four of Circuit 19's Counties to promote the need for foster and adoptive parents. The breakfasts were well attended and there was representation from our two foster care agencies, Camelot and 4Kids.

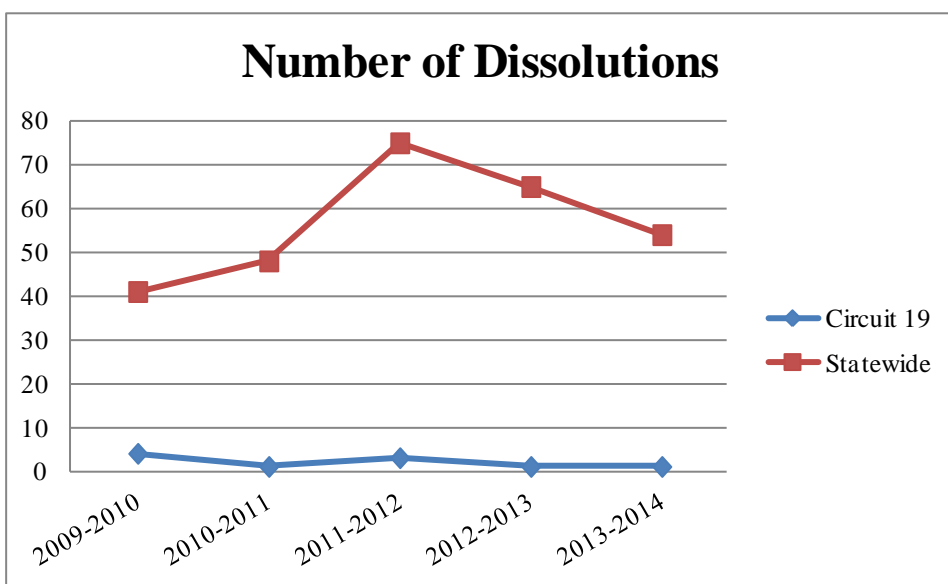

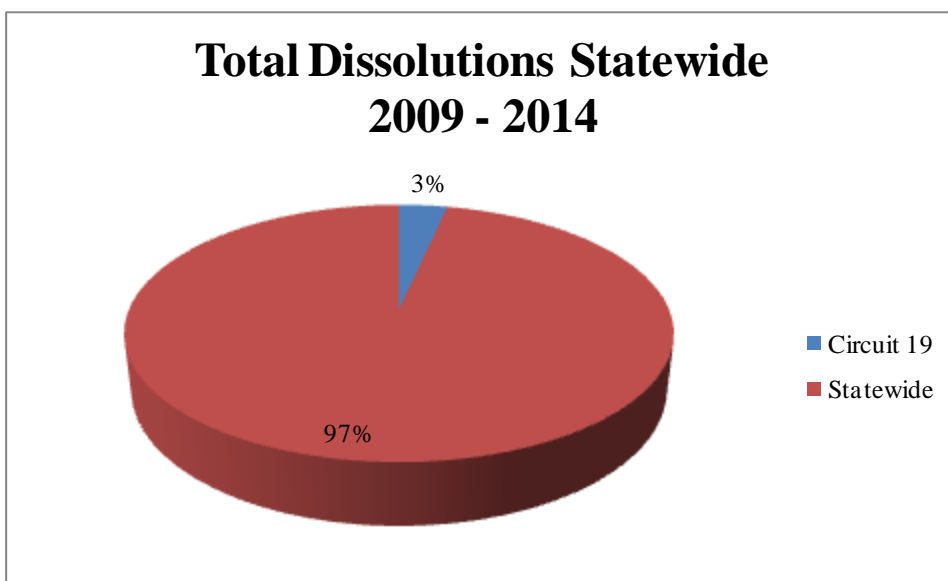

Objective	Status	Summary/Action Needed
Objective 1.1 Develop outline/model of desired support structure by December 2013.	Re-evaluated	As previously reported, due to a minimal response throughout the four counties in our circuit, this objective will need to be re-evaluated for the upcoming five-year plan.
Objective 2.1 Implement support services in each county by December 2015.	Ongoing	Support services are currently offered in each county by Adoption Specialists. Additionally, Adoption Orientation is conducted monthly in St. Lucie County; a new Orientation is slated to take place in Martin County while a quarterly Orientation will be schedule at the new United Way House in Okeechobee County. An Adoptive Parent Support group continues to be offered monthly.

Additional Activities

Interagency Collaboration on Support for Adoptive Families

CHS runs support services for adoptive families who are interested. They have case managers who can work with the family concerning basic crisis management and refer to community resources. In addition the CBC maintains a QPI (Quality Parenting Initiative) which is available for any foster/adoptive parents.
