Applications must include current contact information (especially direct phone numbers), including email addresses, for judges, co-counsel, opposing counsel and references to facilitate the background investigation that will be conducted by the members of the commission. Applicants shall not initiate contact with the commissioners until the nominees are submitted to Gov. DeSantis.

All proceedings of this Judicial Nominating Commission are open to the public except for deliberations. Accordingly, applicants should not expect their application to be kept confidential. If an applicant is nominated, all materials attached to the original application will be submitted to Gov. DeSantis' office.
