OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 13-333 (Executive Order of Suspension)

WHEREAS, Barry Layne Moore (Moore), is presently serving as Mayor of the City of Hampton, in Bradford County, Florida; and

WHEREAS, on November 25, 2013, Moore was arrested by the Bradford County Sheriff's Office on one count of possession of a Schedule I drug and selling a Schedule I or II drug, in violation of section 893.13(1)(a)1, Florida Statutes, each constituting a second-degree felony; and

WHEREAS, section 112.51, Florida Statutes, provides that the Governor may suspend from office any elected municipal officer who is arrested for a felony; and

WHEREAS, it is in the best interests of the residents of the City of Hampton, and the citizens of the State of Florida, that Moore be immediately suspended from the public office that he now holds, upon the grounds set forth in this Executive Order;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, pursuant to section 112.51, Florida Statutes, find as follows:

A. Barry Layne Moore is, and at all times material, Mayor for the City of Hampton, Florida.

B. The office of Mayor for the City of Hampton, Florida, is within the purview of the suspension powers of the Governor, pursuant to section 112.51, Florida Statutes.

C. The attached arrest warrant and affidavit charge that Moore committed felonies in violation of the laws of Florida. This suspension is predicated upon the attached arrest warrant and affidavit, and is incorporated as if fully set forth in this Executive Order.

BEING FULLY ADVISED in the premises, and in accordance with the Constitution and the laws of the State of Florida, this Executive Order is issued, effective immediately:

Section 1. Barry Layne Moore is hereby suspended from the public office that he now holds; Mayor of the City of Monticello, Florida.

Section 2. Barry Layne Moore is prohibited from performing any official act, duty, or function of public office; from receiving any pay or allowance; and from being entitled to any of the emoluments or privileges of public office during the period of this suspension, which period shall be from today, until a further Executive Order is issued, or as otherwise provided by law.


COUNT II: AND WHEREAS the complaint further alleged that **BARRY LAYNE MOORE**, in Bradford County, Florida, **November 23rd 2013**, did then and there unlawfully and for a valuable consideration sell and deliver to a confidential source a controlled substance, to-wit: Roxycodone (Opium or Deriv); contrary to section 893.13(1)(a)(1).

WHEREAS, the Court finds from the facts alleged in said complaint that there is probable cause that said offense was committed and that said Defendant committed them.

NOW THEREFORE this is to Command you to arrest the said **BARRY LAYNE MOORE, INSTANTER**, to be brought before the Court to be dealt with according to law.

Bond is hereby set in the amount of \$5,000, \$30,000 (per count).

PROBABLE CAUSE

On 11/23/2013 at approximately 1245hrs Agents met with C.S. 167 conducted a search of him/her and issued him/her twenty dollars in good and lawful United States currency and official funds on the Bradford County Sheriffs Office to make the anticipated purchase. At approximately 1300hrs C.S. 167 left the meeting location enroute to attempt to contact the suspect. At approximately 1327hrs C.S. 167 contacted the suspect at his residence and had a conversation with the suspect. The suspect stated that he left the pills at his girl friends house if he/she would call him about 5:00 or 5:30 he would have them and he/she could get some. The suspect advised C.S. 167 he did not come home the night before due to the amount of people waiting at his residence when he returned from getting his prescription filled. The suspect provided two phone numbers for C.S. 167 to call (352)870-4937 or (904) 796-3668.

At approximately 1645hrs Agents met with C.S. 167 for the purpose of contacting the suspect to attempt to make the purchase. C.S. 167 was searched for any illegal contraband and none was found. C.S. 167 was equipped with electronic monitoring and recording equipment for the purpose of recording the anticipated transaction. C.S. 167 was issued \$20.00 in good and lawful United States currency and official funds of the Bradford County Sheriffs Office to make the transaction with. At approximately 1658hrs C.S. 167 left the meeting location enroute to the suspect's residence. At approximately 1659hrs C.S. 167 arrived at the suspect's residence and contacted him in his yard. The two had a conversation and C.S. 167 asked the suspect for a pill. The suspect advised that he would give him/her one but he wasn't selling shit to anyone. The suspect advised C.S. 167 to come back and get it, C.S. 167 walked away stating he/she would go lock up Daddy's shed and be right back. C.S. 167 walked away and stated he/she would be right back. The suspect contacted C.S. 167 while he/she was walking back and handed him/her a cigarette pack stating it was inside. C.S. 167 took the cigarette pack and asked if he/she could keep the cigarettes and the suspect stated "hell no". C.S. 167 placed the \$20.00 issued to him/her earlier inside the cigarette pack and handed the cigarette pack back to the suspect.

Agent met back with C.S. 167 and took possession of the pill and identified it as Oxycodone 30mg by its marking via Drugs.com. The suspect was identified from the video of the transaction as Barry Layne Moore w/m 01/12/1962. The pill was placed into evidence at the Sheriff's Office and photo copy of the buy money was placed into the case file.

Before me personally appeared the above named law enforcement officer with the BRADFORD COUNTY SHERIFFS OFFICE, and who being duly sworn, states the Defendant BARRY MOORE did commit the acts stated in this Probable Cause Affidavit. Based upon this sworn statement of facts, I find probable cause that the defendant did commit the crimes listed in the Charges Section of this affidavit. Therefore, I hereby command the immediate arrest of Defendant BARRY MOORE and order them brought before the courts to be dealt with according to the law.
