EXECUTIVE ORDER NUMBER 13-80

WHEREAS, the Honorable JEFFREY A. SIEGMEISTER, State Attorney for the Third Judicial Circuit of Florida, has advised Governor RICK SCOTT that an investigation has been conducted into assertions of forgery made against Circuit Court Judge Paul Bryan and/or other parties; and

WHEREAS, the Honorable JEFFREY A. SIEGMEISTER has also advised the Governor that he is a personal friend with one of the parties involved in the investigation and also Judge Paul Bryan is a sitting circuit court judge in the Third Judicial Circuit; and

WHEREAS, the Honorable JEFFREY A. SIEGMEISTER, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable BRAD KING, State Attorney for the Fifth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interest of the State of Florida and of the ends of justice that the Honorable BRAD KING discharge the duties of the Honorable BRAD KING, pursuant to Section 27.14, Florida Statutes;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable BRAD KING, State Attorney for the Fifth Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable JEFFREY A. SIEGMEISTER, State Attorney for the Third Judicial Circuit of Florida, as they relate to the investigation, prosecution and all matters related to Circuit Court Judge Paul Bryan.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Third Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Third Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including March 18, 2014.

Section 5.

The Assigned State Attorney shall notify the Governor on or before February 18, 2014, if additional time is required.
