EXECUTIVE ORDER NUMBER 15-184

WHEREAS, the Honorable WILLIAM N. MEGGS, State Attorney for the Second Judicial Circuit of Florida, has advised Governor RICK SCOTT that James R. Galloway was arrested, in Leon County, for burglary of a dwelling, aggravated battery with a deadly weapon, aggravated assault with a deadly weapon, criminal mischief over \$200 and under \$1,000, simple assault with intent to do violence, and harassing communication by phone call; and

WHEREAS, the Honorable WILLIAM N. MEGGS has also advised the Governor that James R. Galloway is his nephew; and

WHEREAS, the Honorable WILLIAM N. MEGGS, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable JEFFREY SIEGMEISTER, State Attorney for the Third Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable JEFFREY SIEGMEISTER discharge the duties of the Honorable WILLIAM N. MEGGS, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable JEFFREY SIEGMEISTER, State Attorney for the Third Judicial Circuit of Florida, referred to as the "Assigned State Attorney," is assigned to discharge the duties of the Honorable WILLIAM N. MEGGS, State Attorney for the Second Judicial Circuit of Florida, as they relate to the investigation, prosecution and all matters related to James R. Galloway.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Second Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Second Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.


The period of this Executive Assignment shall be for one (1) year, to and including September 11, 2016.

Section 5.

The Assigned State Attorney shall notify the Governor on or before August 11, 2016, if additional time is required.
