EXECUTIVE ORDER NUMBER 16-229

WHEREAS, Stan L. Greer is presently appointed as a Board Member of the Florida Enhanced 911 (“E911”) Board of Directors; and

WHEREAS, on September 30, 2016, Stan L. Greer was arrested and charged in case number 2016CF003005 in the Second Judicial Circuit of Florida with three counts of Prohibited Use of Computer Services or Devices to Solicit a Parent, Legal Guardian, or Custodian of a Child to Consent to Unlawful Sexual Conduct with a Child, a third-degree felony in violation of section 847.0135(3)(b), Florida Statutes; and

WHEREAS, the Governor is authorized by section 112.52(1), Florida Statutes, to suspend from office an appointed public official who is informed against for commission of a felony; and

WHEREAS, it is in the best interests of the citizens of the State of Florida that Stan L. Greer be immediately suspended from the public office, which he now holds, upon the grounds set forth in this executive order.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, pursuant to section 112.52, Florida Statutes, find as follows:

- A. Stan L. Greer is, and at all times material hereto was, a Board Member of the Florida E911 Board of Directors.
- B. Stan L. Greer is an appointed public official within the purview of the suspension powers of the Governor, pursuant to section 112.52, Florida Statutes.

C. On September 30, 2016, Stan L. Greer was arrested and charged by Information in case number 2016CF003005 in the Second Judicial Circuit of Florida with three counts of Prohibited Use of Computer Services or Devices to Solicit a Parent, Legal Guardian, or Custodian of a Child to Consent to Unlawful Sexual Conduct with a Child, a third-degree felony in violation of section 847.0135(3)(b), Florida Statutes.

BEING FULLY ADVISED in the premises, and in accordance with the Constitution and the Laws of the State of Florida, this Executive Order is issued, effective immediately:

Section 1. Stan L. Greer is suspended from the public office to which he was appointed, to wit: Board Member of the Florida E911 Board of Directors.

Section 2. Stan L. Greer is prohibited from performing any official act, duty, or function of public office; from receiving any pay or allowance; and from being entitled to any emoluments or privileges of public office during the period of this suspension, which period shall be from today, until further Executive Order is issued, or as otherwise provided by law.
