### EXECUTIVE ORDER NUMBER 17-164

#### (AMENDING EXECUTIVE ORDER 17-112, AMENDED BY EXECUTIVE ORDERS 17-127 AND 17-141)

WHEREAS, the State Attorney for the Fourteenth Judicial Circuit of Florida was assigned by Executive Order 17-112, to the First Judicial Circuit of Florida to handle charges pending against Johnny Ray Wilson for driving on a permanently revoked driver's license, possession of harmful new legend drug without prescription, two counts of possession of a weapon or ammo by convicted felon, two counts of grand theft, grand theft of a firearm, petit theft, two counts of possession of a controlled substance without prescription, possession of marijuana (not more than 20 grams), possession and/or use of drug equipment, three counts of fraudulent impersonation of law enforcement officers, and attempted escape; and

WHEREAS, Executive Order 17-112 was amended by Executive Order 17-127 to include additional allegations made against Johnny Ray Wilson for possession of a weapon or ammo by convicted felon, larceny/petit theft first degree and fraudulent impersonation, and amended by Executive Order 17-141, to include the charges of criminal mischief and escape; and

WHEREAS, the Honorable WILLIAM EDDINS, State Attorney for the First Judicial Circuit, has advised Governor Rick Scott that additional allegations have been made against Johnny Ray Wilson for impersonation of a law enforcement officer; and

WHEREAS, the Honorable GLENN HESS, State Attorney for Fourteenth Judicial Circuit of Florida, has agreed to accept the executive assignment to include the additional charges and allegations in these matters.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, do hereby issue the following Executive Order effective immediately:

Section 1.


Executive Order 17-112, amended by Executive Orders 17-127 and 17-141, is hereby amended to include the additional allegation of impersonation of a law enforcement officer.

Section 2.

Except as amended herein, Executive Order 17-112, amended by Executive Orders 17-127 and 17-141, is ratified and reaffirmed.
