EXECUTIVE ORDER NUMBER 17-23

WHEREAS, the Honorable MICHAEL J. SATZ, State Attorney for the Seventeenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Olakunle Omomowo is being investigated for lewd and lascivious molestation of a victim less than 12 years of age; and

WHEREAS, the Honorable MICHAEL J. SATZ has also advised the Governor that Mr. Omomowo was previously charged with similar offenses in three separate cases, all of which were recently nolle prossed, but an attorney representing the victims' families has requested the assignment of another State Attorney to investigate and re-open the cases; additionally, Mr. Omomowo's defense counsel filed a motion to disqualify the Broward State Attorney's Office, alleging the original charges were filed based upon the improper influence of a former employee of the Broward State Attorney's Office, who was then-employed by the law firm representing the victims' families; and

WHEREAS, the Honorable MICHAEL J. SATZ, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable DAVID ARONBERG, State Attorney for the Fifteenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable DAVID ARONBERG discharge the duties of the Honorable MICHAEL J. SATZ, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to “take care that the laws be faithfully executed,” and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable DAVID ARONBERG, State Attorney for the Fifteenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable MICHAEL J. SATZ, State Attorney for the Seventeenth Judicial Circuit of Florida, as they relate to the investigation, prosecution, and all matters related to Olakunle Omomowo.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Seventeenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Seventeenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.


The period of this Executive Assignment shall be for one (1) year, to and including January 30, 2018.

The Assigned State Attorney shall notify the Governor on or before December 30, 2017, if additional time is required.


