The Twentieth Circuit Judicial Nominating Commission announces a judicial vacancy in the Twentieth Judicial Circuit Court resulting from the resignation of Circuit Judge Jay B. Rosman.

The Commission requests that interested candidates submit an application for consideration. Applicants must have been a member of The Florida Bar for the preceding five (5) years, a registered voter and must be a resident of the territorial jurisdiction of the court at the time he or she assumes office.

- One (1) electronic copy
- One (1) electronic copy redacted of any information not subject to public disclosure.

Incomplete applications, obsolete forms of application, and applications received after the deadline will not be considered.
