Telephone: MIAMI – The Eleventh Circuit Judicial Nominating Commission has been asked to provide Governor Rick Scott with nominees for the vacancies in the Miami-Dade County Court created by the resignations of **County Court Judges Dawn V. Denaro, Andrea Ricker Wolfson, and Renatha Francis.**

The Commission requests that interested candidates submit an application for consideration. Applicants must meet the qualifications for county court judges described in Article V, Section 8 of the Florida Constitution and Section 34.021 of the Florida Statutes.

**Applicants must deliver a complete original application by July 20, 2018, at 5:00 p.m. No copies shall be required. Any application delivered after the deadline will not be considered.** The original application should be delivered to:

Applicants are invited to provide the Chair with a one page sheet listing the date, location and time of hearings or trials that they would want the Commissioners to observe. The one page disclosure sheet is not mandatory and can be provided to the Chair at any time before the interview day. *No information other than the date, location and time should be provided on the one page sheet.*
