Applicants must have been a member of The Florida Bar for the preceding five (5) years, a registered voter and must be a resident of the territorial jurisdiction of the court at the time he or she assumes office.

- One (1) electronic copy redacted of any information not subject to public disclosure.

**Incomplete applications, obsolete forms of application, and applications received after the deadline will not be considered.**

Interviews will be conducted during the period Monday, May 23 through Tuesday, May 24, 2016. The list of the candidates who will be interviewed and the schedule of interviews will be announced on Wednesday, May 11, 2016.
