The Sixth Circuit Judicial Nominating Commission seeks applications for nomination from all persons who meet the eligibility requirements set forth in the Florida Constitution. The individual appointed to this position should expect to serve in Dade City, Florida.

Applicants must be able to fulfill the Constitutional qualifications before assuming the office of Circuit Court Judge, which require the person to be a member in good standing of The Florida Bar for the preceding five (5) years, a resident of the Sixth Judicial Circuit, and a registered voter in the State of Florida.

As of August 1, 2014, there have been changes made to the Application for Judicial Seat, including, but not limited to, the requirement to complete a Form 6, Full and Public Disclosure of Financial Interest. Applicants must complete the current Application for Judicial Seat.

Incomplete applications and applications submitted after the deadline will not be considered.
